- 3. The bidders should have satisfactorily supplied books to any 3 Central Universities or Institutes.
- 4. The bidders should have a minimum average annual Turn Over of Rs. 300 Lakhs in last 3 consecutive Financial Year (Certificate should be attached).
- 5. The bidders should not be ever been debarred / blacklisted for doing business from any Government Organization. If No, Please furnish an affidavit raised on non judicial stamp paper of Rs. 100 (Rupees hundred only).
