## **NOTICE**

Subject:-Submission of application for promotion under UGC-Career Advancement Scheme (CAS)

Applications in prescribed format are invited from the eligible Faculty members of Central University of South Bihar (CUSB) for promotion to the next higher stage/grade under the "UGC-Career Advancement Scheme (CAS)". Applications along with self-attested copies of supporting documents should be submitted in four sets to the Registrar, Central University of South Bihar by 10-06-2017 positively duly forwarded through respective Head of Departments/Centers and Dean of the Schools.

Faculty members may kindly note that their cases for promotion shall be considered in accordance with the UGC Regulations for Career Advancement Scheme (CAS) which are in operation on the date of their eligibility.

Those Faculty members who consider themselves eligible for promotion <u>before</u> announcement of UGC (Minimum Qualifications for appointment of Teachers and other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education) (4<sup>th</sup> Amendments) Regulations, 2016 published in Gazette of India on 11<sup>th</sup> July, 2016 are required to submit their application in the format at Annexure-A based on UGC (Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education) (2<sup>nd</sup> Amendment) Regulations, 2013 notified on 13<sup>th</sup> June, 2013 and will have to follow the system of capping for API scores.

Faculty members who consider themselves eligible for promotion under Career Advancement Scheme (CAS) <u>on or after</u> publication of UGC (Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education) (4<sup>th</sup> Amendments) Regulations, 2016 published in gazette of India on 11<sup>th</sup> July, 2016 are required to apply in Proforma at Annexure-B.

The Proforma for scoring API as per Performance Based Appraisal System (PBAS) attached to this notice has to be filled-in as per the scoring pattern prescribed in UGC respective Regulations cited above. The cases of promotion under CAS shall be governed by the UGC (Minimum Qualifications for appointment of Teachers and other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education) Regulations, 2010 and its subsequent amendments from time to time as the case may be.
