NOTICE

Subject:-Submission of application for promotion from one academic level/stage to another academic level/stage under Career Advancement Scheme (CAS).

Applications in prescribed format are invited from the eligible faculty members of Central University of South Bihar (CUSB) for promotion to the next higher academic level/stage under the Career Advancement Scheme (CAS). Applications along with self-attested copies of supporting documents duly forwarded by respective Head of Department and Dean of the School should be submitted in five sets to the Coordinator, IQAC, Central University of South Bihar by 10-12-2018.

Such faculty members who consider themselves eligible <u>on or after</u> the publication of UGC (Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and other Measures for the Maintenance of Standards in Higher Education) Regulations, 2018 published in Gazette of India on 18th July, 2018 may kindly note that their cases for promotion shall be considered in accordance with the provisions contained in Clause 6.4 of the said UGC Regulations, 2018.

Those Faculty members who consider themselves eligible for promotion <u>before</u> the notification of aforementioned UGC Regulation – 2018 and have not submitted their application so far are required to submit their option (please see Clause 6.3 & Clause 6.3 -VII) in the prescribed format (Annexure – 1) for being considered for promotion either by UGC Regulation-2010 and its amendments or UGC Regulation-2018 as the case may be and accordingly shall submit the application form in relevant proforma.

Such faculty members who have already submitted their application for consideration for promotion under CAS under 2nd Amendment/4th Amendment of UGC (Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education) Regulation, 2010 are required to submit their option (please see Clause 6.3 & Clause 6.3 -VII) for being considered for promotion either by UGC Regulation-2010 and its amendments or UGC Regulation-2018 as the case may be and accordingly shall submit the application form in relevant proforma, if needed.

The Proforma for applying for promotion under CAS as per Grading/Scoring system based on Assessment Criteria and Methodology Guidelines defined in UGC Regulation- 2018 (Annexure-2) and API based Performance Based Appraisal System (PBAS) of UGC Regulation 2010 (Annexure-4) are attached to this notice. The faculty members are required to fill-in the proforma as per the option exercised by them and as per the scoring pattern prescribed in UGC respective Regulations cited above. The applicants are also requested to fill-in the summary sheet (Annexure-3 as per UGC Regulation 2018 & Annexure-5 as per UGC Regulation 2010 and its amendments) of the score/grade claimed for promotion under CAS and enclose the same with their application form.
