2	Clause No. 3.1 Performance Gurantee of 10% if extended till defect liablility period, we understand from payment terms 5the Stage, 10% retention is not required from RA Bills.	As per GFR, only 10% of the order value or executed value whichever is higher shall be retained till defect liability.
3	We understand, there is no liquidated damage and incentive clause in this tender.	<b>Liquidated damage shall be applicable as per University Ordinance and Purchas Rule &amp; Procedure (PRP) which is available on University's website.</b>  There is no Clause of incentive under present Tender Notification.
4	Considering, varied texture and type of natural wood, we request you to kindly show samples of hard wood so that competitive pricing can be done.	Sample of Hard wood & Rexine is available in the office of CUSB at Panchanpur. Bidders must get themselves fully satisfied before offering their price.
5	With effect from 01.07.2017, GST shall be implemented and on furniture, it will be @ 28%. We understand that you shall consider GST in place of VAT as written in Bill of Quantity.	Any implication arising out of change in Government Policy and/ or order shall be considered as per Government Rule.
6	Qur company is registered with NSIC. We request you to exempt us from earnest money deposit and tender fee. For your reference, scanned copy of certificate is attached herewith.	Micro & Small Enterprises registered with NSIC only will be exempted from payment of Tender Fee and Earnest Money Deposit subject to submission of valid certificate.

7	<p>GST: GST will be applicable from 1st July 2017. The rate of GST on furniture is 28%.</p> <p>Request: We request you to allow us to quote rates excluding taxes. Although the rate of GST is 28%, there is no clarity until 1st July 2017. Further there may be some amendments/ modification in the near future. Invoice should be raised with the prevailing rate of GST at the time of delivery of furniture. Taxes should can be paid extra as applicable by the University.</p>	<p><b>Yes, the rate should be quoted excluding taxes, but including all other charges. The GST/VAT rates whichever applicable will be payable.</b></p> <p>Any implication arising out of change in Government Policy and/ or order shall be considered as per Government Rule.</p> <p><b>(All participants are requested to note this.)</b></p>
8	<p>As of now there is no clarity on GST tax rates, we request you to allow local billing through our authorized dealer in Bihar.</p>	<p>Authorized dealers to be declared along with bidding documents with a request to Tender Inviting Authority for consideration of the same. However, above authorization shall not relax Bidders in any obligation towards terms of the Tender.</p>
9	<p>Head-rest to be covered with 2mm thick rexin: 2mm thick rexin is not available in the market. We have checked with some major brands producing rexin in India. None of them are producing 2mm thick rexin.</p> <p>Request: We request you to allow us to use rexin thickness from 0.8mm to 1mm, whichever is available from reputed brands.</p>	<p>Thickness of Backing materials also considered while arriving actual thickness of Rexin. For Clarity, the actual coating thickness of Rexin should not be less than 1.00 mm.</p>
10	<p>Clarification in existing Clause 3.2.2</p>	<p>On request of Bidders Clause No. 3.2.2 is modified as under: Vendor shall submit samples of each of unpolished and polished hard wood of Red Sheesham, 2nd Class Teak, BWR grade block board and Rexine material etc matching with the samples demonstrated during Pre-bid meeting within 7 days from the date of receipt of LOA and Owner shall give comments/ approval in writing for specific samples within 7 days of receipt of samples. All materials to be consumed for the work viz. hard wood, block boards, laminates, hardware and fixture to be got approved by the Owner before put on use.</p>
11	<p>New Clause to be added</p>	<p>In event of any discrepancy in specification of any item, the order of precedence shall be as follows: 1. Bill of Quantity 2. Drawings 3. Specification 4. Scope of Vendor</p>
12	<p>New Clause to be added</p>	<p>Bidders are requested to quote rate for all items of Bill of Quantity. Rate quoted in part items shall be summarily rejected.</p>
