The percentage of service charge as quoted by all the bidders were inclusive of 2% T.D.S. amount and other components i.e. Salary of Security Service Officials, 2 sets of Summer Uniforms, 2 sets of Winter Uniforms, 1 pair of Shoes to all the deployed personnel, Kits, Torch, Bicycle, proper washing of uniforms, Stationary, Incidental Expenses related to Security Personnel etc. has to be met by the Agency.

Deducting 2.0% as Income Tax, it does not **seems to be reasonable** of the price quoted as service charges i.e. 0.01% to meet all other expenses by the Service Agency, viz. M/s. Security Solution Services, Bareilly, in accordance with Ministry of Finance, Department of Expenditure, the Manuals on Policies and Procedures for Purchase of Goods, issued vide letter dated 31<sup>st</sup> August 2006, point No. 11.7.1, reasonableness of price "Before placing the contract on the lowest evaluated responsive tender (L-1), the purchase organization is to ensure that the price to be paid is reasonable".

As such, as per the comparative sheet as stated above in table has been taken into consideration for other vendors excluding M/s. Security Solution Services, Bareilly. The rate quoted by M/s. Security & Intelligence Service (I) India Ltd., New Delhi, for service charges @ 3.36% inclusive of T.D.S. is @ 2.0%.

The committee is of the opinion that the service charge rate quoted as 3.36% inclusive of T.D.S. seems to be reasonable of M/s. M/s. Security & Intelligence Service (I) India Ltd., New Delhi and which may be considered as L-1.
