ORDER

WHEREAS, in terms of Section 14(1) of the NCTE Act, Central University of Bihar, House No. 16/13, Ward No. 9A, New Area Bisar, Nootan Nagar, Gaya-823001, Bihar has applied for grant of recognition for 4 year Integrated B.A. B.Ed. and B.Sc. B.Ed. course for Four years duration under section 14(1) of the NCTE Act, 1993 and hardcopy received by Eastern Regional Committee of NCTE on 11.02.2014.

AND WHEREAS, on scrutiny of the application submitted by the institution, the documents attached therewith, the affidavit submitted and the report received from VT and videography, and the certificates received from the University, the Committee is satisfied that the applicant fulfils the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the said teacher education programme such as instructional facilities, infrastructural facilities, financial resources, etc., for running the programme.

NOW THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Eastern Regional Committee, NCTE hereby grants recognition to Central University of Bihar, House No. 16/13, Ward No. 9A, New Area Bisar, Nootan Nagar, Gaya-823001, Bihar for conducting 4 year Integrated B.A. B.Ed. and B.Sc. B.Ed. programme of Four years duration with an intake 100 (two basic units) from the academic sessions 2015-2016 under Clause 7(16) of NCTE (Recognition Norms & Procedure) Regulations, 2014 subject to fulfillment of the following conditions:-

- I. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- II. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations 2014.


The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

1. The institution shall comply with the additional facilities required (such as additional staff, additional funds etc) for the second shift as prescribed in NCTE (Recognition Norms and Procedure) Regulations 2014 before 31.12.2017.
2. Further the recognition is subject to the condition that the institution shall move gradually to become a composite institution but not later than 2016-2017.
3. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University / Body, the State Government etc, as applicable.
4. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
5. The institution shall maintain its Website with hyperlink to the Council and the Eastern Regional Committee, covering, inter-alia, the details of the institution, its location, name of the programme applied for the intake; availability of physical infrastructure, such as land, building, office, classrooms and other facilities or amenities; instructional facilities, such as laboratory and library and the particulars of their proposed teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-
  - a) Sanctioned programmes along with annual intake in the institution;
  - b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c) Name of faculty members who left or joined during the last quarter;
  - d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
  - e) Fee charged from students;
  - f) Available Infrastructural facilities;
  - g) Facilities added during the last quarter;
  - h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
  - i) The affidavit with enclosure submitted along with application.
  - j) The institution shall be free to post additional relevant information. If it so desires.
  - k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

6. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
7. The institution shall make available list of students admitted on its official website.
8. If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the regional committee under the provisions of Section 17(1) of the NCTE Act.

The following Act of Parliament received the assent of the President on the 10th January, 2019, and is hereby published for general information:—

### THE NATIONAL COUNCIL FOR TEACHER EDUCATION (AMENDMENT) ACT, 2019

No. 2 of 2019

[10th January, 2019.]

An Act further to amend the National Council for Teacher Education Act, 1993.

BE it enacted by Parliament in the Sixty-ninth Year of the Republic of India as follows:—

1. (1) This Act may be called the National Council for Teacher Education (Amendment) Act, 2019. Short title and commencement.

(2) It shall be deemed to have come into force on the 17th day of August, 1995.

2. In the National Council for Teacher Education Act, 1993 (hereinafter referred to as the principal Act), in section 14, in sub-section (1), after the proviso, the following proviso shall be inserted, namely:— Amendment of section 14.

“Provided further that such institutions, as may be specified by the Central Government by notification in the Official Gazette, which—

(i) are funded by the Central Government or the State Government or the Union territory Administration;

(ii) have offered a course or training in teacher education on or after the appointed day till the academic year 2017-2018; and

(iii) fulfil the conditions specified under clause (a) of sub-section (3), shall be deemed to have been recognised by the Regional Committee.”.

Amendment  
of section 15.

3. In section 15 of the principal Act, in sub-section (1), the following proviso shall be inserted, namely:—

“Provided that the course or training in teacher education offered on or after the appointed day till the academic year 2017-2018 by such institutions, as may be specified by the Central Government by notification in the Official Gazette, which—

(i) are funded by the Central Government or the State Government or the Union territory Administration; and

(ii) fulfil the conditions specified under clause (a) of sub-section (3), shall be deemed to have been granted permission by the Regional Committee.”.
