*The Vice-Chancellor apprised the members with the progress made in respect of Admission Process of various programmes of the University. He conveyed that the admission process for 4*

*UG Integrated Programmes has been set in motion at Gaya Campus of the University under the guidance of Admission Committee and for 16 PG Programmes admission process has also been initiated, which is likely to be completed by mid-August.*

*He detailed that the University was sanctioned 140 faculty positions for 20 Programmes in XI Plan and till 2012-13, the University launched 16 Master programmes covering 112 (16x7) faculty positions.*

*To utilize remaining 28 faculty positions, Academic Council and Executive Council decided to launch 5 year integrated Law with two streams BA.LLB (Hon's) and BSc.LLB (Hon's). As five year integrated requires teaching in a number of subsidiary subjects (English, Economics, History, Physics, Computer Science, Chemistry, Life Science, etc.) Academic Council may consider allotting at least 14 positions at this stage and additional 14 positions after couple of years, after launching of the programme.*

*As per MHRD and UGC under 12<sup>th</sup> FYP directive, the University has launched Four Year Dual Degree BA.BEd and BSc.BEd from Academic Year 2013. The University has already submitted a proposal to UGC for fund for School of Education to meet requirements.*

*The Academic Council was also apprised with the Executive Council decision related to faculty advertisement taken in its 13<sup>th</sup> Meeting held on June 13, 2013.*

*The Academic Council considered the decision of Executive Council and suggested to prepare a comprehensive review of positions for future expansion and projection for the 12<sup>th</sup> FYP.*

- 3. Elective Courses- courses under Elective basket should be not listed, if not offered and only listed when course instructor with these specialisation are available.*
- 4. A student may take and should be encouraged to take additional courses over and above requirement, from other programme with the permission of CAC of Department/Centre. However, the grade in such courses must not be taken into consideration for calculation CGPA but may be shown separately.*

*The Academic Council resolved that suggested changes be incorporated in course structure for approval by the Vice-Chancellor on behalf of the Academic Council.*

*The Academic Council considered the recommendation of Admission Committee and also national policy of MHRD to promote teaching of Urdu language and shortage of quality Urdu secondary School teachers and resolved to approve two (2) seats as supernumerary in BA.BEd. Programme for the students opting URDU as a subject with a pre-condition that*

*they will continue with Urdu subject for four years and the admission committee shall report to Executive Council and to Academic Council (each year). Such Supernumerary provision shall be subject to review after three years by a Committee.*
