At the outset the Vice-Chancellor welcomed all the members present in the 17th meeting of the Academic Council. While welcoming he made a special mention to the new Head/ Head (I/c) of Departments who have been nominated as ex-officio members of the Academic Council. The Vice-Chancellor informed that Prof. Prabhat Kumar Singh, former Head, Department of English and Ex-Member of the Academic Council has been appointed the Pro Vice-Chancellor of Purnea University, Purnea and relinquished CUSB on 19-04-2018. The Academic Council unanimously <u>resolved</u> to place on record its appreciation and gratitude for the services rendered by Prof. Prabhat Kumar Singh who made a great contribution as a faculty and as an administrator at temporary campus at Gaya during the transitional phase.

The Chairman to apprise the members of the Academic Council about the infrastructural progress of the University, shifting of temporary academic wings to the permanent campus, admissions in different programmes for session 2018-19 and recruitment of faculty members on contract in different Departments of the University.

Resolution No. 03/AC-17/18

The Vice-Chancellor presented a brief account of progress of infrastructural development of the University and shifting of temporary premises to the permanent campus, new academic programmes, admissions made in academic year 2018, appointment of faculty members and academic initiatives that took place since the last meeting of the Academic Council held in March, 2018.

The Vice-Chancellor detailed the members about the progress of campus development at permanent site of the University. He apprised the members that after having completed the construction work of two school buildings, lecture hall complex, hostels and the external development works, the University is ready to function with all its academic and administrative set up from its own and integrated permanent campus at Panchanpur, Gaya. Recollecting the day 31st August, 2015, just after three week of assumption of charge as Vice-Chancellor of CUSB, when the foundation stone was laid down by the then Minister of Human Resource Development Smt. Smiriti Irani, the Vice-Chancellor shared with the members about the efforts that made the campus functional within three years its foundation.

He expressed his gratitude to all the faculty members of the University who have been persistently making their best effort in sifting their classroom furniture and equipment and to install in the permanent campus. The Vice-Chancellor especially acknowledged the relentless hard work rendered by the Executive Engineer of the University Sh. Rajeev Kumar Upadhyay who left no

stone unturned in order to make this strenuous task possible. The Academic Council placed on record its deep sense of appreciation to Sh. Rajeev Kumr Upadhyay, University Executive Engineer for his effort to make the campus functional before start of the session.

The Vice-Chancellor shared that considering the proposal of the University for requirement of faculty members the UGC has sanctioned 18 new positions for Department of Commerce & Business Studies and Department of Law & Governance and also made 13 faculty positions permanent in Department of Teacher Education. He apprised that now the total sanctioned strength of faculty members in 22 Departments has increased to 184. The Vice-Chancellor informed that recently the University has made the appointment of 35 faculty members on temporary basis to meet the teaching requirement for the new programmes of studies in current session.

The Vice-Chancellor briefed the members about the academic programmes and admissions made thereunder for the session 2018-19 through CUCET. He said that hitherto the University was constrained to restrict student's intake in various programmes due to space crunch at rented premises of the University. The shifting of academic wings and offering of programmes from permanent campus from this session has given the freedom to increase the student strength as per standard teacher student ratio. Apart from that, from this Academic Year 2018 five new Postgraduate Programmes in Physics, Chemistry, Commerce, History and Social Work have been started and one new section of Five Year BA.LLB (Hons.) Programme with 60 intake has been added. He informed that out of total 1008 intake in all the Undergraduate and Postgraduate Programmes approx. 700 students have been admitted so far.

Highlighting the future priorities of the University, the Vice Chancellor elaborated upon the expansion plan of the University like Staff Quarters, Health Centre, Ph.D. Hostel and new Academic Blocks and apprised about the proposal submitted to HEFA in this regard. He emphasized that all support shall be provided to the faculty in their pursuit for excellence in teaching and research.

The Vice-Chancellor drew the attention of the members towards the new initiatives of the Government of India on the policy front and the transformations being carried out in the field of higher education. He said that to deal with the changing scenario and to fulfil the mandate of quality education it was necessary to identify the key issues, build on the earlier efforts and take a

step ahead. He further added that Central University of South Bihar has completed nine years of academic journey since its inception in 2009. The present Academic Year 2018-19 is a remarkable year in the history of the University as from this year the University shall be functioning with all its academic and administrative activities from its permanent campus. Simultaneously, in course of onward journey the University has decided to undertake the academic reforms keeping in view of the transformations being carried out in the field of higher education.

He said that in this endeavour the University has taken a big leap towards the academic restructuring. The University already had Choice Based Credit System (CBCS) system in the different PG Programmes since inception and curricula of the programmes were also designed in framework of credit courses and categorized as core and elective. But, more or less, the choices were restricted to courses offered within the Departments. In order to roll out the effective implementation of CBCS in letter and spirit and furthering the existing CBCS to inter-Departmental and inter-School level rigorous meetings of Deans and Heads were conducted. Now, the University has come up with a more flexible and 'student-centric' rather than 'system-centric' or 'teacher-centric' system of CBCS. Also, in order to streamline the conduct of programmes of studies under different Departments Academic Ordinances for each programmes have been framed by the University.

The Vice-Chancellor apprised that Dr. Kaushal Kishore, Professor in School of Education has been appointed as Nodal Officer who steered the effective implementation of CBCS and played a key role to prepare the Model Ordinance in CBCS framework. The Vice-Chancellor expressed his thanks to the Pro Vice-Chancellor under whose leadership all the Heads of Departments and Deans of Schools completed a series of brainstorming meetings to implement CBCS and framed academic ordinances.

The Academic Council noted the effort made for improvements on academic fronts and placed on record sincere appreciation to the Vice-Chancellor for these initiatives. The Council further extended its appreciation to Pro Vice-Chancellor and prof. Kaushal Kishore for their hard work in this endeavour.
