At the outset the Vice-Chancellor welcomed all the members of the Academic Council who were present in the meeting. He especially welcomed the external members of the Academic Council and thanked them for sparing their valuable time for attending the meeting.

The Secretary then, with the permission of the Chair, presented the brief of the agenda items to be taken up during the meeting. Thereafter, the agenda items were taken up for discussion in seriatim.

Resolution No.02/ AC-21/22	<p>The Secretary reported the Action Taken as a follow up and compliance of the decisions of 20th Academic Council held on 18th November 2021.</p> <p>The Academic Council took a note of it and <u>resolved</u> to accept the Action Taken Report (<u>Annexure–‘2’ Page No. 1-16</u>).</p>
Item No. 03/ AC-21/22	The Chairman to apprise the members of the Academic Council about the Academic Activities of the University.
Resolution No.03/ AC-21/22	<p>The Chairman presented a brief account of progress of the University encompassing teaching and research, admission process and other academic activities that took place since the last meeting of the Academic Council held on 18.11.2021.</p> <p>The Chairman apprised that the University has accomplished many set targets in the last one year. He detailed that in pursuance of the implementation of the National Education Policy 2020, all Programme of Studies offered by the University has been revised by the Board of Studies of the respective Departments in the new framework developed by the ‘Task Force for implementation of NEP 2020’. The revised course structure and syllabus of all the Programme of Studies are placed in this meeting in the following agenda items for consideration and approval.</p> <p>Apprising about the admission process for the AY 2022-23, the Chairman briefed the members that, the entrance test for admission in all the Programmes of Studies except Ph.D. Programmes, has been conducted by National Testing Agency (NTA) and subsequent to declaration of results of CUET(UG)-2022 and CUET(PG)-2022, the admission process in all Undergraduate, Postgraduate and Postgraduate Diploma Programmes are being made on the basis of merit.</p> <p>He informed that so far three rounds of admissions have been completed and more than one thousand admissions in different Programmes have been made. The admission process for Ph.D. programmes has been carried out by the University itself.</p> <p>The Chairman informed that despite the situation arising out of Covid-19, the University remained successful in maintaining its Academic Calendar.</p> <p>Apprising about the 2nd Cycle of NAAC accreditation of the University, the Chairman detailed that all the formalities regarding submission of SSR have been completed and in all likelihood, the SSR will be submitted in the last week of December, 2022.</p>

The Chairman informed that the University has received the approval of NCTE to run the M.P.Ed. programme and from AY 2022-23, this programme will be started with 40 intake. He further informed that one more programme of study i.e. M.A. / M.Sc. in Geography has been started by Department of Geography from this AY 2022-23. In addition, M.Phil. in Clinical Psychology Programme has been proposed to be started from the next Academic Session with the approval of the Rehabilitation Council of India.

The Chairman apprised the members that Ministry of Social Justice and Empowerment, Government of India has approved to establish Dr. Ambedkar Centre of Excellence (DACE) in Central University of South Bihar, that will offer coaching to the students belonging to SC category for preparation of Civil Services Examination conducted by UPSC. He informed that 100 students have taken admission in the DACE and their classes are running smoothly.

The Chairman briefed the members about the activities performed by the Departments. He informed that in the last one year 16 sponsored research projects have been sanctioned to the faculty members of the university by different funding agencies. He apprised that the University administration has initiated a single window system for instant resolution of the issues related to research projects.

The Academic Council considered the briefing of the Chairman and **resolved** to approve the decisions taken by the Vice-Chancellor on behalf of the Academic Council and the action taken thereon during the intervening period.
