  - (a) Centre for Indian Languages
- 9. School of Media, Arts & Aesthetics shall consist of the following Centres, namely:
  - (a) Centre for Mass Communication and Media
- 10. School of Management.

**Resolution No.03/AC-5/11** The Academic Council discussed the proposal and considered a number of suggestions-

- the word "Guidelines" be replaced as "Regulations".
- the 'Thesis' work done during M.A./M.Sc. shall be referred to as 'Dissertation'
- the 'Thesis' work done during M.Phil./Ph.D. be referred to as 'Thesis'.
- each thesis shall be examined by TWO (2) examiners, including the Supervisor of the thesis. The Second Examiner shall be selected from among the CUB faculty members by the Board of Studies.
- a detailed Guideline for Master's Dissertation be prepared and made available for all M.A./M.Sc. students working on dissertation as Regulations..

The Academic Council also <u>resolved</u> to recommend to the Executive Council for approval, after incorporating the above suggestions.

To consider the recommendations of the Dean, School of Social Sciences & Policy for award of M.A. in Development Studies to those students of 2009-2011 session who have successfully completed all requirements of M.A. in Development Studies (vide <u>APPENDIX-'4'</u>) (To be circulated on the table).

Resolution No.04/AC-5/11 The Chairman apprised the members about the intake and drop-outs of the first batch of MDS students (2009-2011 session), the 9 point grade scale and also about the placement of approximately 90% students of this batch in various organisations including institution for higher studies across the country.

The Academic Council <u>resolved</u> to record its appreciation, congratulatory note and best wishes to the first batch of MDS students who are the torch bearers of this University.

The Academic Council further <u>resolved</u> to recommend to the Executive Council for its approval to award Degree to the students of 2009-2011 batch who have successfully completed their M.A. programme in Development Studies.

The Academic Council discussed the CGPA in detail the way transcript should present over-all grades and results in terms of percentage and the Division..

The Council constituted a Committee comprising of Prof. A. K. Bhatnagar, Prof. A. Laxminath and Prof. R.K. Sinha to consider the grade scale being followed and also to consider inclusion of Excellent, Outstanding and Distinction' remark in the Degrees transcript of students.

#### Resolution No.05/AC-5/11

The Academic Council resolved to recommend to the Executive Council for its approval to launch M.Phil.-Ph.D. programmes in Environmental Science and Development Studies / Economics in the session 2011-2012.

#### Agenda No.06/AC-5/11

To consider the Ordinances for Ph.D. Programme as recommended by the Committee constituted by the Executive Council (vide APPENDIX-'6').

Resolution No.06/AC-5/11 The Ordinances framed for Integrated M.Phil./Ph.D. Programme was discussed in detail and the Academic Council resolved to propose to the Executive Council with the following amendments/replacements for approval -

- Clause 1.2.3- (replace as) "60% marks in Humanities or Social (a) Sciences (or a CGPA of 6.5 in 10 point scale)."
- Clause 1.2.4- (replace as) "Relaxation in admission of (b) SC/ST/OBC and others, if any as per the GoI/UGC rules."
- Clause 2.2- (replace as) "Candidates who possess qualification (c) as laid down in clause 1.2 are recommended for admission on the basis of:"
- Clause 2.2.3- (replace as) "Students who have qualified UGC / (d) SLET / GATE / Teacher Fellowship holder or M.Phil. degree

holder may not be exempted from written test and require to appear in the interview only."

- (e) Clause 3.1- (delete) "They can be classified as UGC JRF/SRF/University Fellow(UF)".
- (f) Clause 3.7- (addition) "The total number of students to be enrolled under Clause 3.3 to Clause 3.6 should not exceed 25% of the total candidates to be enrolled under this programme.
- Clause 3.4- (replace as) "In-service category: Staff members of the University may be allowed to enrol themselves for the Integrated M.Phil./Ph.D. programme subject to (a) prior approval of the Vice-Chancellor, (b) fulfilment of the eligibility criteria 1.2 and 2.2, and (c) evidence showing s/he is able to attend the course work and devote to research as per stipulation, (d) sanction of study leave for the entire period to the Administrative staff and (e) sanction of study leave to the academic staff for the period of course work and the remaining period to be adjusted and treated as part time with their research work".
  - (h) Clause 5.2.2- (replace as) "(a) Submission of the M.Phil. dissertation within six(6) months after completion of the courses required for M.Phil; and, its equivalent; (b) Further extension of six months for submission of thesis may be allowed with the approval of the SRDC; (c)The maximum period of extension should not exceed additional one year."

(i) Clause 6.3.2.1 - (replace last sentence) "However, such decision may be taken on case to case basis with the approval of the Academic Council."

(j) Clause 8 – (replace as) "Viva Voce: The following is the composition of the Viva Voce Board:-

Chairman: Supervisor

Members: (i) One faculty member of the University
but from outside the Centre/Department with interest in the thesis
related research. This expert should be nominated and identified
by the URDC and shall receive a copy of the thesis before the
Viva Voce is conducted; (ii) One of the external Examiners who
has evaluated the thesis.

The coordinator of DRDC/CRDC shall coordinate with the Viva Voce Board for conduct of the Viva Voce.

The Academic Council while deliberating <u>resolved</u> to appreciate the Ordinances of IIT, University of Hyderabad, Presidency University Kolkata, University of Allahabad, UGC regulations dated 13<sup>th</sup> June 2010 and UGC model ordinances. The Academic Council further <u>resolved</u> to make regulations for credits, and

grading of courses, Comprehensive examinations, checking of plagiarism, style of the thesis and quality of Ph.D. thesis. The Council also suggested that the Ph.D. work should be of such a quality that one or more quality papers should be of publishable out of it in quality journals.

The Academic Council <u>resolved</u> to approve the Ordinances with incorporation of the above suggestions.

To seek suggestions on draft Ordinances related to Academic matters (vide APPENDIX-'7')

#### Resolution No.07/AC-5/11

The Chairman at the outset briefed about the draft Academic Ordinances and explained the importance of valuable inputs of the Hon'ble members. The entire ordinances were discussed at length and the Academic Council resolved to recommend the Academic Ordinances to the Executive Council for approval along with the following proposed amendments:-

- (a) Insertion of a Preamble before the Academic Ordinances Section.
- (b) In the Ordinance related to "Assignment of Departments/Centre to School" the Centre for the Study of Social System under School of Social Sciences and Policy should be renamed as Centre for Sociological Studies. It was also proposed to delete the Centre under School of Education.
- (c) It was proposed that under the Ordinance related to "Admission, Enrolment, Teaching, Continuous Evaluation and record of students" the Pro Vice-Chancellor/Senior most Dean should be the Chairman of the UATEC.
- (d) It was proposed that under the Ordinance related to "the Proctor, Clause No. 5 should be read as the Proctor shall be the Secretary of the Discipline Committee, and s/he shall convene the meetings of the committee and shall maintain its proceeding.
- (e) It was proposed that under the Ordinance related to "the Proctor", "Clause No. 17" should be inserted before the sentence "the Proctor shall perform such other functions as the Vice-Chancellor may direct from time to time".
- (f) It was proposed that under the Ordinance related to "Students Discipline and Discipline Committee", the code of conduct as detailed in the Ordinances of the University of Allahabad may be incorporated.



Arising out of the discussion, the Academic Council resolved to recommend the Executive Council to frame under Section 28 (1) (0) of the Act, and incorporate by insertion as Clause 15(6) appropriate place, a Statute for assigning the creation or abolition of Departments/Centres under the existing Schools to the Ordinances-

Clause 15(6)-

" The creation or abolition of Departments/Centres under the existing Schools shall be by adding or amending or repealing the Ordinances by the Executive Council."

The Academic Council further resolved to recommend to the Executive Council that as per Section 19(6) of the Act, incorporation of a Statute, that each School Board shall be an authority of the University at the appropriate place, by adding clause 15(2)(a)-

Clause 15 (2) (a) "Every School Board shall be an authority of the University".

Resolution No.08/AC-5/11 The Academic Council resolved to record the academic calendar of teaching and office for the year 2011 and recommend it to the Executive Council for its approval.

1. The Academic Council <u>resolved</u> to record and recommend to the

Executive Council for approving the following-

(a) The Chairman apprised the members about the letter sent to the Hon'ble HRD Minister, GoI based on the resolution of the Academic Council taken in its last meeting. He also briefed about the persisting space constraints, the non-cooperative attitude of the BIT management and that no major break-through or advancement has been made till date on this front. In the coming session the University has no option but to run its classes in two shifts. The Council also resolved that vacant / unused land / property of the Central Government be identified and brought to the notice of MHRD with request to explore all possibilities for locating the University at a site and also to consider a possible transit facility in the capital city of Bihar.

(b) The members were also apprised about vacation of the premises hired in Gardanibagh and shifting of the boy's hostel to Patliputra

Colony.

(c) The members were also apprised about the extension of the tenure of the existing Guest faculty for another term (one semester) up to 30<sup>th</sup> December, 2011.

(e) The Council members were also briefed about engagement of Guest-faculty in 3 subjects, viz. — Bio-informatics, Communication & Media Studies and Counselling Psychology and commencement of regular selection process for Faculty positions in 5 subjects, viz. - Computer Science, Development Studies, Environmental Science, Mathematics and Statistics.

2. The Chairman apprised the members about the proposal for establishment of a Research Centre on River Ecology in Patna. He also briefed about the consent and the enthusiastic and positive response received from Shri Kapil Sibbal, Hon'ble Minister, HRD, GoI, during the discussion held with him on his recent visit to Patna.

The Academic Council <u>resolved</u> to record and approve setting up of such a Centre and agreed that a detailed proposal be prepared and submitted at the earliest to the UGC, MHRD and the State Government for allotment of land for it.

3. The Academic Council <u>resolved</u> to approve the proposal of the Babu Jagjivan Ram Chair as per the UGC Scheme in the Centre of Conflict Resolution and Harmony.

The meeting ended with vote of thanks to the Chair.
