The Chairman apprised the members with the site issue and its likely finalization by the MHRD in consultation with the State Govt. He also

explained that with the launching of new programmes and the ongoing admissions in 17 Master Programmes in the forth coming academic session, as well as recruitment of faculty and staff, CUB has reached a point of crisis calling for an immediate additional space to run classes for about 500 students and to accommodate over 50 faculty and 50 administrative staff. He also briefed that in the absence of any directive from MHRD, CUB is not in a position to make alternative arrangement at any other location and all efforts to rent any other place in Patna has not been successful. The MHRD is being continuously apprised about the critical situation related to requirement of space for the University.

The members were detailed about the on-going work related to the faculty recruitment and the procedure adopted for shortlisting of the candidates for interview in various subjects which will be held from 25th June to 14th July, 2012. Pursuant to this the recommendation of these Committees will be put up before the Executive Council in its last meeting scheduled to be held on 18th July, 2012.

The Chairman explained that with completion of three years the term of the first Executive Council and Academic Council is coming to an end in July 2012 and therefore it is imperative for the University to increase faculty strength to make viable constitution of Executive Council and Academic Council beyond July 2012. The Chairman also explained the problem being faced in recruitment at senior positions including Professors and Associate Professors because of directive of the UGC to implement the New Pension Scheme to even those who are enjoying pensionary and other related benefits in their present organizations.

The Academic Council <u>resolved</u> to record the current situation of the University and expressed its concern about the continuing indecision on the permanent site. They also expressed the view that the University may prepare a contingency plan including teaching in shifts. Opening of Community College exclusively for women was also suggested.
