At the outset the Coordinator welcomed all the members and after this the agenda items were taken:-

To discuss the finalization of MoU format for Academic and other collaborations

Resolution

At start the coordinator welcomed all members of IQAC for a crucial meeting which could lead to a new dimension for the university to grow. He explained the role of a MoU in the current scenario for the global recognition of the institution, and also explained its role in providing an opportunity to mutually collaborate with other eminent organization for incremental growth and recognition of the University. The members thereon laid upon their view on importance and mutual benefit of participating institutions in such MoU's for exploring the possibilities between CUSB and other organization in terms of research projects, joint organization of seminars, conferences, schools, training programmes, exchange of faculties/students. However, members unanimously suggest for the need of drafting a clear guideline and/or regulation about the policies to govern before such MoU's. Moreover, they suggested to prioritize the underlying objective to achieve for excelling the University based on our priorities and to create a solid pave way for global collaborative research activity. In this regard, the members suggested to constitute an internal committee for drafting a format with a clear guideline so that a collaborative activity in the academic and/or research areas of mutual interest among participating institution can be identified and such MoU's can be initiated. Members asked the coordinator to take this initiatives by chairing the constituted committee on his end.
