


Minutes of the Meeting of the Board of Studies

Agenda of the Meeting: The agenda of the meeting were-


1. To update, upgrade and modify, if required, the syllabus of MA English in compliance of the "Model Framework For Implementation of National Education Policy-2020".

3. To prepare and develop the syllabus of English (Two courses of 02 credits each) for B Sc. Programme.


