importance of field work for MA in Social Work students, it was also decided that the expenditure related to visit of Resource Persons during Special Orientation Programme related to Field work and for Special Lecture in each semester; and field visit of students with faculty members (as per the decision of Departmental Committee) and Stationary related to Field work will be adjusted from the amount paid by the students (Rs. 5000/- per semester by each student of MA in Social Work). Departmental Committee will take decision regarding it which will be sent to the competent authority for the approval. . It was also decided that in the fee structure of MA in Social Work Rs. 5000/- is charged in the name of FIELD VISIT only, now it should include FIELD VISIT, ORIENTATION, SPECIAL LECTURE, etc. The Board further recommends the syllabus to the Academic Council for its approval. The Committee authorized the Departmental Committee (DC) to adapt the Ordinance of the Programme and Course Code of different courses of MA in Social Work as per the decision of the University. The Board further recommends the syllabus to the Academic Council for its approval. (Annexure-2).

3. As per the decision of the Executive Council (44th meeting, held on 18-01-2022), a two credit course (Course Code: SOC 904: Research and Publication Ethics) was added in Ph.D. (Sociology) programme. It will be a part of pre-registration Course Work, now total credit will be 16 in Ph.D. (Sociology) programme (Annexure-3).
