ABOUT COMPETITION COMMISSION OF INDIA

Competition is the means to ensure broad ranges of goods and services to common people at the best prices. Increase in competition maximizes innovation and specialization in producers resulting in wider, cheaper and quality choices. The Competition Act is a law governing commercial competition in India replacing the Monopolies and Restrictive Trade Practices Act of 1969. It aims to prevent activities that have adverse effects on Indian Competition. It believes in the creation and sustenance of fair competition in the economy with a goal to provide a 'level playing field' to the producers and transform markets in the economy more consumer welfare centric. The Competition Act, 2002, passed in the year 2002 and accorded assent in 2003 by the parliament and the president respectively, was further amended by the Competition (Amendment) Act of 2007, resulting in the establishment of two statutory bodies namely the Competition Appellate Tribunal (CAT) and the Competition Commission of India (CCI). The provisions in relation with anti-competitive agreements and abuse of dominant position were later notified on 29th May, 2009 in the Competition Act.

The CCI or the Competition Commission of India is an important statutory body that acts as the competition regulator in India. Aiming to establish a sustainable competitive environment in the Indian Economy through proactive engagement with all the stakeholders, the government, and the international jurisdiction the commission schemes for the prevention of practices that harm competition, promotion and sustenance of competition in markets, protecting consumer's interests and ensuring the freedom of trade. Attainment of the above mentioned aims of the CCI are ensured by the functions interpreted through the preamble of the Competition Act itself which focuses on the overall development of economy by promoting constructive competitions and avoiding unfair competitions.

Major functions of the CCI are, to ensure the maintenance of welfare and benefit of customers in the Indian Markets, accelerate economic growth through ensuring fair and healthy competition in the nation, ensuring efficient utilization of nation's resources through complete and proper execution of competition policies, competition advocacy, scrutinizing foreign companies in Indian Markets, ensuring interaction and cooperation between several other regulating authorities in the economy, and acting as a business facilitator, by ensuring no dominance of a few firms in the whole market with peaceful co-existence of small and large enterprisers. The CCI is also the antitrust ombudsman for small organizations.

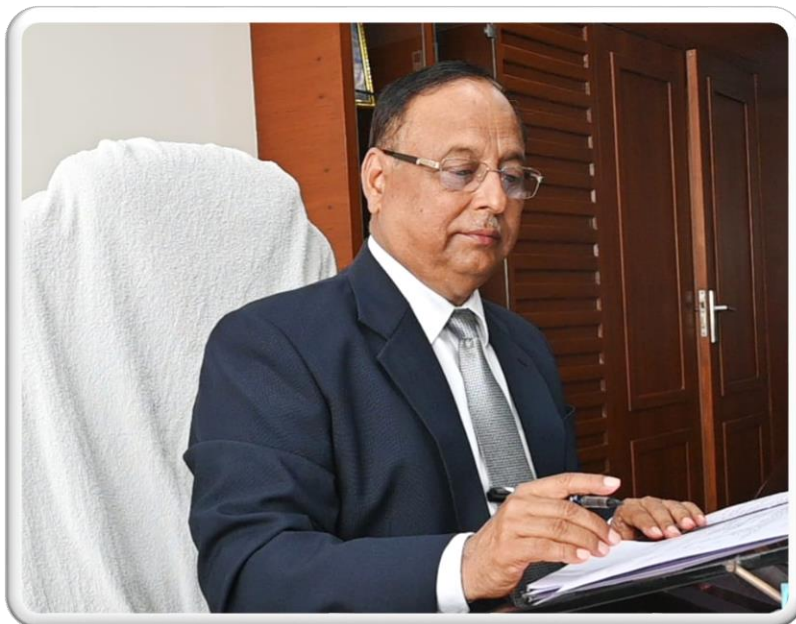

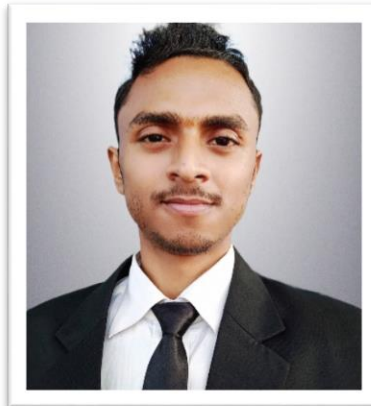
