**ADMISSION NOTIFICATION FOR DDT SUPPORTED POSTGRADUATE PROGRAMS IN
 BIOLOGICAL SCIENCES ACADEMIC YEAR 2023-24**

Applications on the prescribed format are invited through online mode from the eligible candidates (GAT-B-2023) qualified for admission to DDT supported M.Sc. in Biotechnology programme for the academic session 2023-24.

2. Admission shall be made on the basis of merit (GAT-B score) obtained through Graduate Aptitude Test-Biotechnology (GAT-B 2023) conducted by the National Testing Agency (NTA) through DDT Regional Centre for Biotechnology (RCB), Faridabad - 121001 for the year 2023.

3. Eligibility Criteria for admission :

Bachelor's degree in Biotechnology or any branch of Biological Science (Microbiology/ Biochemistry/ Biophysics/ Environmental Science/ Biomedical etc.) or B.Sc. (Hons) in Zoology/Botany/Chemistry or B.Sc. / Integrated B.Sc. B.Ed. of three year duration with any of the two subject among Zoology, Botany & Chemistry in 3rd year with a minimum of 50% marks for General / OBC/ST candidates and 50% marks for SC/ST/PWD candidates from any recognized University.

5. Candidates who are desirous to take admission in M.Sc. Biotechnology programme offered by Central University of South Bihar for Academic Year 2023-24 are required to register themselves on CUSB Portal through **NRI Bandh** (go to NRI E-collect → choose state as Bihar → choose Educational Institution as Central University of South Bihar) → Pay Registration Fee for DDT Student by paying the registration fee (non-refundable) amounting to Rs.500/- for General/EPWS and Rs.200/- for SC/ST/PWD from **04.06.2023 to 04.08.2023**. 6. The candidates are required to check the eligibility criteria before applying for admission to DDT (OBC)-supported M.Sc. Biotechnology program at the Central University of South Bihar.

7. Admission to M.Sc. Biotechnology program will be done solely on the basis of the valid GAT-B score card conducted by NTA through the Regional Centre for Biotechnology (RCB), Govt of India of the candidate.

8. A category-wise waiting list will be prepared as per the merit of GAT-B score and displayed on the University website (refer to the admission schedule for dates).

9. However, deposition of programme fee shall not guarantee the provisional admission in programme. Provisional admission will be granted solely in order of merit and subject to fulfillment of eligibility criteria.
