**ADMISSION NOTIFICATION FOR DBT SUPPORTED POSTGRADUATE PROGRAMME IN BIOTECHNOLOGY: ACADEMIC YEAR 2024-25**

Applications on the prescribed format are invited through online mode from the eligible candidates (GAT-B 2024 qualified) for admission to DBT supported M.Sc. in Biotechnology programme for the academic year 2024-25.

2. Admission shall be made on the basis of merit (GAT-B score) obtained through **Graduate Aptitude Test-Biotechnology (GAT-B 2024)** conducted by the National Testing Agency (NTA) through DBT Regional Centre for Biotechnology (RCB) for the year 2024.

**3. Eligibility Criteria for admission:**

*Bachelor's degree in Biotechnology or any branch of Biological Science (Microbiology/ Biochemistry/ Bioscience/ Environmental Science/ Biomedical etc.) or B.Sc. (Hons) in Zoology/Botany/Chemistry or B.Sc. / Integrated B.Sc. B.Ed. of three year duration with any of the two subject among Zoology, Botany & Chemistry in 3rd year with a minimum of 55% marks for General / OBC/EWS candidates and 50% marks for SC/ST/PWD candidates from any recognized University.*

5. Candidates who are desirous to take admission in **DBT Supported M.Sc. Biotechnology** programme offered by Central University of South Bihar for Academic Year 2024-25 are required to fill the google form ( <https://forms.gle/U2q3ijfYRaJeC4L9>) and register themselves on CUSB Portal.

6. The candidates are required to check the eligibility criteria before applying for admission to DBT (GOI)-supported M.Sc. Biotechnology program at the Central University of South Bihar.

7. Admission to M.Sc. Biotechnology program will be done solely on the basis of the valid **GAT-B score/rank (conducted by NTA through the Regional Centre for Biotechnology (RCB), Govt. of India)** of the candidate.

8. A category-wise waiting list will be prepared *as per the merit of GAT-B score* and displayed on the University website (refer to the admission schedule for dates).

9. However, deposition of programme fee shall not guarantee the provisional admission in programme. Provisional admission will be granted strictly in order of merit and subject to fulfillment of eligibility criteria.



10. Candidates should ensure before registration that they have appeared in **GAT-B** for the specified Programme.

11. It is to be noted that only those candidates can deposit the full programme fee who have registered themselves for admission on the portal within the stipulated timeline and uploaded all the requisite documents.
